Further to my earlier email please note that the Department has the following comments:

- There is a considerable difference between the layout proposed in this application and the layout as previously approved by the Department. It is noted specifically that the previous layout had a larger portion of no-go area in the southwestern corner whereas the new proposed layout has larger areas of no-go areas in the northeastern and southeastern corners. It would be instructive if there could be a comparison between the specialist reports that informed the two layouts in order for the Department to understand any changes that may have taken place on site from a biodiversity perspective.
- It is noted that there is only an Option B provided for the locality of the sewer pump station. This implies that other options were also considered but it is not evident what these may have been. Furthermore, it seems that the sewer pump station as per option B is located within the nogo area in the southeastern corner.
- The main road that traverses the property bisects two no-go areas one on the north of the property and one in the southeastern part of the property. This begs the question as to whether it is really necessary to have a road that traverses the southeastern no-go area or whether it would not be possible to only have the one main entrance along the northern part of the property and have secondary accesses along Michael Angelo Avenue and Brahms Avenue. This will negate the bisecting of the forest that occurs in the southeastern corner.
- As the proposed development, if authorised, will require the clearance of some indigenous forest, it is imperative to secure comment from the Forestry Branch of DFFE.
- Please ensure that there is official confirmation from the NMBM that the bulk services are available
 and have the capacity to accommodate the proposed development, if such has not already been
 provided in the DBAR.

PROPOSED RESIDENTIAL DEVELOPMENT OF ERF 325, THEESCOMBE, QGERBERHA, EASTERN CAPE

In response to your comments received via email on 12 September 2025, see below response.

Comment 1: There is a considerable difference between the layout proposed in this application and the layout as previously approved by the Department. It is noted specifically that the previous layout had a larger portion of nogo area in the southwestern corner whereas the new proposed layout has larger areas of no-go areas in the northeastern and southeastern corners. It would be instructive if there could be a comparison between the specialist reports that informed the two layouts in order for the Department to understand any changes that may have taken place on site from a biodiversity perspective.

Response 1: Your comment is noted; however, the previous Biodiversity Assessment is not available to EAS at this moment, hence a comparison of the previous and current specialist report is not possible. The previous layout and existing layout were shared with the Biodiversity Specialist. The specialist's recent digitization of the no-go areas was based on more recent survey detail conducted over several days and based on recent aerial images. In the specialist's opinion, the changes that may have taken place on site over the past 5-10 years in terms of a biodiversity perspective may be due to the following activities:

- Increase in alien tree cover
- Increase in illegal waste disposal, which has resulted in several areas of garden escapee plants from establishing
- Several months of wood harvesting (Rooikrans firewood harvesters) that created or opened up tracks
- Small informal settlement that encamped in a small forest patch, but was then transformed
- Clearing of alien vegetation and general areas in preparation for the installation of roads and services to enact the previous authorisation, which with Covid never started so the 5 years lapsed. This also resulted in a changing in the vegetation and an increase in alien vegetation
- Creation of large berms to block the above wood cutters access at the repetitive entrances of the site


In summary, several events or activities have resulted in various degrees of clearing and or habitat alteration mostly through clearing, alien growth and dumping of waste over the past 10 - 12 years. The key areas that were mapped and included in the no-go areas made the most sense in terms of being viable biodiversity units, that could be self-supporting as opens space habitats and or connected to habitat corridors that exit beyond the site. The mapped open space areas, also had the highest presence of protected plant and tree species within the site.

The above will be included in FBAR for consideration.

Comment 2: It is noted that there is only an Option B provided for the locality of the sewer pump station. This implies that other options were also considered but it is not evident what these may have been. Furthermore, it seems that the sewer pump station as per option B is located within the no-go area in the southeastern corner.

Response 2: Option A (preferred alternative) which is not necessarily labelled on the map below is the preferred option which will connect into the existing sewer network within Chopin Rd and is indicated below as the dark purple line. Option B is an Alternative method if required, as indicated by the lighter purple line. The Engineering Report (Appendix D5) and facility Illustration in Appendix C provide further details. The FBAR submission will clearly label Option A (preferred alternative) for clarity purposes (below image).

Due to the contours of the land, the Option A sewer servitude is the only practical alignment for the gravity sewer and needs to traverse some of the No-Go area. Our DBAR clearly shows all unpreventable loss of No-Go areas due to service alignments (boundary fence, stormwater, sewer network etc.) to ensure there is clear communication with all stakeholders.



Comment 3: The main road that traverses the property bisects two no-go areas — one on the north of the property and one in the southeastern part of the property. This begs the question as to whether it is really necessary to have a road that traverses the southeastern no-go area or whether it would not be possible to only have the one main entrance along the northern part of the property and have secondary accesses along Michael Angelo Avenue and Brahms Avenue. This will negate the bisecting of the forest that occurs in the southeastern corner.

Response 3: According to the TIA, access to the development has been planned such that traffic will approach along the most practical and direct routes from Glendore Road, namely Merle Road via Gladys Road, Blumberg Road via Michelangelo Avenue and Chopin Road. This will ensure that impact on these streets is kept to a minimum while at the same time evenly distributed.

Additionally, due to the negative traffic impact on the surrounding suburb the development may cause, the public consultation meetings provided the community an opportunity to voice their opinion on the secondary access route and generally, Chopin Rd was deemed the preferred secondary access route.


Engineering services such as sewer connections are required to be connected to the existing network on Chopin Rd, which would require further disturbance. There is an existing disturbance (jeep track) also bisecting the two nogo areas in the Southeast corner.

Additional mitigation measure to the secondary access road will be incorporated into the FBAR such as:

- ensuring that "beware of wildlife signs" are installed,
- internal speed limits are restricted to 20km/h,
- mountable kerbs are installed so animals such as tortoises do not get trapped on the road bisecting the forest that occurs in the southeastern corner.

Comment 4: As the proposed development, if authorised, will require the clearance of some indigenous forest, it is imperative to secure comment from the Forestry Branch of DFFE.

Response 4: A site inspection with DFFE was undertaken on 24/10/24 and an attendance register, which was mistakenly left out of the DBAR, will be included in the FBAR (Comments and Responses Report). Additionally, we will ensure that an extra attempt to get comment from DFFE on the DBAR will be made (see below email and attendance register).

I hereby confirm that the reservoir has sufficient capacity to cater for this development, however the supply pipelines are over committed. Water is available, subject to:

A water supply main pipeline extension in Glendore Road from Gladys Road to Michaelangelo Road.

The Municipal By Law Clause 30, General Conditions of Supply states:

"The granting of a supply of water by the Municipality will not constitute an undertaking by it to maintain at any time or at any point in its water supply system:-

- a) an uninterrupted supply
- b) a specific pressure or rate of flow in such supply; or
- c) a specific standard or quality of water."

SANS 10252-1:2012, Water Supply and drainage for buildings, clearly states that the above must be taken into account and where the local authority's water supply is not capable of providing sufficient pressure and rate of flow for fire installations, storage tanks are required.
